First Families & Presby Kids continues to be a vital ministry, giving families of elementary age children opportunities to enjoy fellowship with one another. The "Spring Splash" at the Holiday Inn and the "Day at the Farm" (thank you to Dan and Christine Holland) are traditions. In the fall, we enjoyed an outing to the "Pumpkin Patch" at Rocky Creek Farm and a children's Christmas movie featuring Spark Sunday School favorite, Squiggles, who apparently was with Mary and Joseph at Jesus' birth!

Youth Ministry – In the spring, the youth of the church planted a tree in the church's yard on Willson Ave., as stewards of creation. Thanks to Dan Berg for coordinating this. The 10:30 a.m. service has continued with our pastors; Alison Todd, organ and piano; Joanna Ellison, organ and piano; Jay Pontius-Backman, organ; Matthew O'Sullivan, organ; Russell Milburn, Worship Choir Director; and Kathy Braun, First Bells Director. Larry Growney takes careful and thorough care of the sanctuary and also provides flute solos and accompaniment throughout the year. The choir members are dedicated, each spending about three hours per week in creating music for the worship service, with special efforts by Jill Brauss. Kathy Braun, and Jay Pontius-Backman, shared leadership for the choir directing in Spring 2016, while Russell Milburn was on leave of absence. At least 60 congregants are involved in greeting/ushering each Sunday and in serving communion on the first Sundays of the month. John Patterson has joined Session and is serving on the Worship Committee. Charlie Mandeville faithfully prepares the communion elements each month, with Christine Holland taking over the preparation of the communion elements in late 2016. The Deacons generously provide cookies and beverages after each service.

Some of the activities that have continued to occur include:

- Worship Planning Team meetings each two weeks involving Pastors Dan and Jody, Alison Todd, Russell Milburn, Joanna Ellison, and now John Patterson.
- Having a variety of guests in the pulpit including the Presby Cats, youth of the church, the adult mission trip participants, and the Mount Ellis school choir.
- Kathy Braun, serving as Special Musical Events coordinator. She has brought outstanding
 musical events to the church. The 2016 concerts featured a diversity concert in January, Organist
 Mark Anderson in May, and an October concert honoring those who have passed away.
- Alison Todd has continued to schedule a song leader at each service to provide leadership for congregation singing.
- Participating in the community Thanksgiving service at the United Methodist Church.
- Actively seeking feedback about the worship service from congregants through the Ombuds person appointed by Session.
- Organizing a fourth annual Advent service.
- Continuing to host the community "Messiah" sing, thanks to Kathy Braun.
- Ending the year with the Blessing of the Animals at the Christmas Day service, which was the finishing touch to a wonderful series of Christmas services, beginning with the Rockhaven service in mid-December, a Christmas Eve family service with the children acting out the nativity scene, a service at 8:00 p.m. featuring the choir and other music, and then a contemplative 11:00 p.m. service with beautiful music and candlelight.

MISSION AND OUTREACH 2016 ANNUAL REPORT

At First Presbyterian Church, we seek to live as Christ in our world, moving into the neighborhood where Christ leads us. We partner with many others to be "doers of the word" (James 1:22). Our congregation looks outward for ways to share God's love with the world.

Four special offerings are taken each year sponsored by PC (USA):

- One Great Hour of Sharing
- Pentecost Offering, Peacemaking

- Offering and the Christmas
- Joy Offering

We continue our denominational mission with a commitment to unified-giving to the Presbytery of the Yellowstone, Synod of the Rocky Mountains and General Assembly headquartered in Louisville, KY.

Local mission opportunities were many this year:

Adult Mission Trip: In 2016, 11 members of our congregations deepened the relationships which began in 2015 with three Dakota Presbyterian Churches and one Yellowstone Presbyterian Church (First Presbyterian Church of Poplar). Our fellowship time with members of the churches was memorable. At the Mnisda church in Chelsea, a major job was the replacement of the three wooden crosses which stand near the highway and the railroad. We also did yardwork around the church building. We were delighted to hear later in the summer that the church's roof was replaced by another mission group. At the Makaicu church at Riverside, we updated the cemetery records which we had made in 2015. The extensive cleanup of the cemetery we did in 2015 apparently provided the boost needed for the congregation to resume maintenance of the grounds, because the need for yardwork was much less in 2016. At the Red Eagle Church at Fort Kipp, we did yardwork and worked to improve the threshold of the door on the "new" church building. This work was completed later in the summer by a Presbyterian mission team from the Chicago area.

Love INC: John Patterson is a member of the Board (past president), Gayle Hickert and Teri Nightingale were our FPC's Ministry Coordinators with Sandy Archer as backup for most of 2016. Bill and Katie Anderson have taken on this task for 2017. We continue to support the Personal Care Pantry, the Plant the Seed Dinner, and the Clothes Closet. Joy Ames organizes a large team to work at the Clothes Closet one Saturday each month and is asking for more volunteers for the 2-hour assignment one Saturday a month. Other volunteers provide help at the Love INC office doing intake and referrals.

Family Promise: A nation-wide interfaith organization providing shelter and opportunities for homeless families. We have housed families since its inception in Bozeman in 2008. During 5 different weeks in 2016, we provided homes to 6 different families (2 families here more than one of the weeks). Judy Arkwright is our Coordinator, with Nancy Rote in charge of food and Judy Harrison and Cheryl McNicholas in charge of volunteers.

Dan and Sandy Archer are hugely appreciated for their continued clean-up each Sunday morning as the families leave and Archers ready our church for Sunday worship. Betsy Crabs and Mary McMakin have served as Board Members. The Belgrade LDS Wards continue to serve as our Partner Church during our weeks. We have an urgent need for more volunteers to help with this program, particularly the overnight stays – which are actually the easiest job with the least responsibility.

Cardboard Box City is a major fundraising project for Family Promise held each Fall. Thank you to supporters willing to give and supporters willing to show their solidarity with homeless people by sleeping in a box. For the second year in a row our church won the grand prize at the Cardboard Box City: Most Money Raised! Lenka Swenson, Hannah Koch, Julia Johnson, Zoe Helrigel, Rodney Aloise, Gigi Swenson, Mary McMakin, and Brent, Rachel, Delia, Jolene, & Arden Turner all braved the cold, rain, thunder, lightning, and hard concrete of the pavilion at Bogert Park on Saturday night, Oct 1, sleeping in cardboard boxes they decorated for their homes. The evening included education about homelessness in Gallatin Valley, as well as entertainment. This was the 10th year that Family Promise has hosted this fundraiser, and First Presbyterian Church has participated every year. As of Oct. 3, contributions through FPC totaled more than \$2000. Thank you to all who supported this effort this year.

Community Café: The Gallatin Valley Food Bank provides a meal every evening for those in need. We continued our support of this program through October, 2016. We will be looking for a new project to replace it.

Crop Walk: Judy Mathre for 29 years has organized our church and our community for this event.

Operation Christmas Child: Joy Ames continues to organize our boxes, which are sent worldwide. This year 410 boxes were filled (an increase over last year of 25 boxes).

None of this would happen without the dedication of the wonderful volunteers from our church.

Summer Camp 2016

This past summer we offered a total of 8 camp sessions; which breaks down to 4 weeks of day camp, 1 leader in training camp, 1 elementary overnight camp, 1 teen adventure camp and 1 day camp plus camp. We also had a number of CIT's or Jr. Counselors involved for the full summer season which proved quite successful. The Day Camp Plus was very popular and will be offered again in 2017.

Again, we broke the previous summer attendance records. In 2016 every session was either at or above capacity and many weeks saw deep waitlists. A total of 300 camp registrations not including the volunteer Counselor's in training.

The continuing support and generous giving from FPC members to the campership fund allowed us to award \$4,440 to families who would have otherwise not been able to attend camp.

Operational Board 2016

The primary goal of the operational board in 2016 was to develop a long range strategic plan that consist of a general facility plan, a financial plan and an overall program outline. The board has

been working with an architect to develop a facility plan for multiple year phases. This plan includes expansion of our adventure courses to better serve campers and the community, a rain shelter pavilion, a new play feature, modern east side multi-use cabins, updated kitchen facilities, improved parking, paths and lighting and ultimately a dormitory remodel. Details and drawings of these plans are still being finalized and will be available in the near future.

Retreats, Facility Rentals, Special Events and outreach to other users and groups:

Rockhaven continues to grow as an option for retreats and meetings for local churches and groups. Schools regularly utilize our facilities for field trips, play days and our adventure based programming. Part of our long range plan addresses ways to better serve these types of organizations during the shoulder seasons through high and low ropes course programs and improved facilities.

Camp Parent Interviews:

The board conducted parent interviews again this fall which provided excellent feedback and some valuable suggestions. The response from parents about the program at Rockhaven continues to be overwhelmingly positive.

Looking Forward:

This coming spring we plan to begin the building of a new play space and structure, a low ropes team challenge course and some updating of the high ropes course.

Also in 2017 we will launch our new Jr. Counselor program which will consist of 3 paid youth to serve as program support staff during the summer camp season. It will be an exciting new ministry that will continue the outreach to youth that are approaching the "in between" years of camper to staff.

Rockhaven is making a growing impact on the community because of the many prayers and support we receive from the congregation at FPC, the board and others through their time, talent and treasures. We look forward to 2017 and another successful, faith filled season of camping ministry.

Board of Deacons 2016 Annual Report

The mission of the Deacons is to provide compassion, witness and service, sharing in the redeeming love of Jesus Christ for the poor, the hungry, the sick, the lost, the friendless, the oppressed, those burdened by unjust policies or structures, or anyone in distress. The Board's first concern shall be to the congregation. Secondly our mission shall also extend outside of the church by the building of bridges between the church and community (from our Mission Statement, adopted February 4, 2016).

The Deacons work is financially supported by the Congregation through your pledges and offerings, and we want to thank you by telling you some of the ways we used your money in 2016. The Deacons helped with a variety of activities, mostly focused on those with significant needs, in keeping with our mission.

Here in Gallatin County, about 14% of the population is living in poverty. One of our programs focused on the children of those who are poor is the warm clothing drive. The Deacons work with Bozeman Schools as well as Gallatin Gateway and Monforton schools, along with community organizations such as Thrive, to provide coats and gloves and boots to children. This year, 101 kids were helped, and a total of \$4,462 was spent on the clothing drive. We received great cooperation from JC Penney. They helped us get significant discounts that allowed us to buy more for the children and also coupons, which the Deacons used to buy additional adult hats, gloves and socks that were donated to the Warming Center.

Just before Easter and Thanksgiving, the Deacons coordinate the organization and delivery of food baskets to those families identified by Thrive as needing help. At Easter, the Deacons and other church members delivered 47 baskets at a cost of \$2,107. Prior to Thanksgiving, we provided 65 baskets at a cost of \$3,480. We receive excellent cooperation from Heeb's East Main Grocery, and each "basket" is a box of food that can supply a family with two or three meals.

An indicator of the importance of the Deacons mission is emergency assistance. In 2016, 17 gas, food, or rent assistance vouchers were provided at a total cost of \$871. Requests are screened to help ensure appropriate aid is being provided.

In another example of community support, the Deacons have helped the school nursing programs at Monforton and Gallatin Gateway schools for over a decade. Did you know that 20% of the students at Monforton qualify for reduced cost or free lunches? At Gallatin Gateway, the percent of students that qualify for free or reduced cost lunches is 35%. Each of the school nurses spends an estimated 40 to 50% of their time with poorer students, often serving as those student's primary medical care-giver. Church funding cover one-third to one-half of the nursing program costs. Because of a change in Superintendent and staff at Gallatin Gateway and a new Moderator for the Deacons, Gallatin Gateway did not request reimbursement from the church in 2016. The Deacons provided \$4,000 in funding for the Monforton School Nursing Program.

We used some of that available funding to reach beyond the church and community to help disaster relief in Tennessee and Haiti through Presbyterian Disaster Assistance (total of \$1,000).

Closer to home, the Deacons support the congregation through caring meals, and in 2016, seven families were supported. We gave rides to members to church, to the doctor or to physical therapy and other places. Rides were provided regularly to three individuals and occasionally to two others. We hosted several receptions for funerals and music events in 2016. A really important part of congregational help is visiting church members who cannot attend services. Deacons and other church members met, called, or checked in on about 30 members over the course of the year, and in 2017, we will be stepping up our efforts on visitation.

The Deacons manage the kitchen on behalf of the church, and directly or indirectly support a wide variety of church programs that utilized the kitchen over the course of the year. In 2016, \$1,665 was spent on kitchen-related items. Finally, on the home front, the Deacons host Sunday morning coffee and cookies after each service, and we thank all of you who helped bake dozens and dozens and dozens of cookies to help all of us enjoy some sweets with our coffee and tea.

Because of your generosity over the years, in 2016 the Deacons had the opportunity to make some one-time expenditures, totally \$7,400. These were to Love, Inc.: \$1,000; Rocky Mountain Medical Ministries (supplies for Mexico medical trip): \$700; Presby Cats Mission Trip to Ireland: \$1,700; Warming Center: \$500; Community Café: \$500; Food Bank: \$500; Gallatin County Sheriff's Department Chaplain: \$500; Congregational Luncheons: \$1,000; and Rockhaven Scholarships: \$1,000.

Offerings to the Deacons in 2016 were somewhat below the \$20,000 annual projection, totaling \$17,333. Our 2016 expenditures (excluding kitchen and one-time) were \$16,693 (all figures are rounded, and some miscellaneous expenses are not included in the above narrative).

The 2016 – 2017 Board of Deacons includes: Darlene Haller, Betty Knutson, Jay and Bruce Pontius-Backman, Mimi and Mike Roser, Teri Nightingale, Marilyn Lockhart, Kay and Cinclair May, Nancy Rote, Mary Hektner and John Sacklin, Nancy Rutkowski, Caralyn Hodgson, Judy and John Harrison, Sammylu Parsons, Judy Arkwright, Madelyn Montgomery, and Rachel Minteer.

The Deacons also want to acknowledge the five years that Bob Olsen was moderator (and six years that he and Cherie were Deacons). Their terms ended mid-year, and they provided many years of devoted service to the Deacons. Thank you Bob and Cherie!

The work of the Board of Deacons is really the work of this church at its best – bringing the meaning of the words of our Lord Jesus Christ to the congregation and community through actions and deeds. Thanks again for making this possible.

PRESBYTERIAN WOMEN 2016 ANNUAL REPORT

Presbyterian Women is an association of women within the church providing fellowship in their gatherings to nurture their faith through Bible Study and prayer, to work for justice and peace, and to build a caring community of women who strengthen the church and support the worldwide mission of PC(USA).

PW is comprised of circles that meet for fellowship and Bible study. Circle A meets in members' homes on the third Wednesday morning of the month September through May. Campus Circle meets every Monday evening through the school year at the church. A third group, Lydia Circle, met September through May in the church every two weeks on Wednesday afternoons, but is temporarily not meeting this school year. All circles use the annual *Horizons Magazine* guidebook for Bible study. Books and DVDs were also used for study, discussion and special topics.

The Bible studies we use are nine lessons published each year by Presbyterian Women's *Horizons Magazine*. In 2016 January through May we completed the study called *Come to the Waters* by Judy Record Fletcher. September through December we began the study: *Who is Jesus? Cash salary of: \$31,656

Housing allowance of: \$13,260

Pension & Health dues: \$16,394

Retirement savings: \$1,296

Study allowance: \$1,500

Mileage allowance: \$800

Total budgeted cost: \$129,812 for both co-pastors

This represents a 2% increase in terms of call over 2016.
